## Prairie Village Phase III Development

Councilman Schoneboom moved that the Governing Body accept and authorize the development proposal for Prairie Village III submitted by Heartland Housing Partners. The motion was seconded by Councilman Claycamp. Discussion.

Councilman Claycamp moved to delay the decision to gather drainage and paving information. The motion was seconded by Councilman Smith. Motion passed 3-2. Councilmen Schoneboom and Ghormley were opposed.

Councilman Schoneboom moved to postpone the motion to accept the proposed contract with Heartland Housing Partners until August 31<sup>st</sup>, 2022. The motion was seconded by Councilman Claycamp. Discussion. Motion passed 5-0.

Councilman Claycamp moved to recess the meeting until August 31, 2002 at 7:00 p.m. The motion was seconded by Councilman Smith. Motion passed 5-0.

Mayor Gottschalk called for a vote on the original motion to accept the Heartland Housing Partners contract. Vote to accept the contract was opposed 2-3. Councilmen Claycamp, Smith and Swift were opposed.
