# **Approve Bonuses**

Councilman Schoneboom moved to approve an annual bonus for nonelected full time city personnel of 1% to be calculated based on individual annual earnings from the first pay period on or after December 1, 2020 through the pay period ending on or about November 30, 2021. The motion was seconded by Councilman Ghormley. Motion passed 5-0.

Luis Alicea, city IT service provider, requests approval of \$1600.00 plus labor to purchase hard drives to update server. Councilman Schoneboom moved to approve the purchase of hard drives. The motion was seconded by Councilman Claycamp.

After discussion Councilman Ghormley moved to postpone the decision. Motion was seconded by Councilman Schoneboom. Motion failed 2-3. Councilman's Ghormley and Schoneboom voted in favor. Councilman's Claycamp, Swift and Smith voted against.

Original motion by Councilman Schoneboom to approve the purchase passed 3-2. Councilman's Claycamp, Swift and Smith voted in favor. Councilman's Schoneboom and Ghormley voted against.
