New Business

Curt moved to accept Nick Engels offer of \$18,000 for the 6 lots. No second.

Other Business

Curt reported he and the City Administrator met with Ty Lasher, City Administrator of Bel Aire to discuss Bel Aire's annexation experiences. Mr. Lasher suggested that an independent consultant be retained by Benton to conduct listening sessions with residents in the proposed annexation neighborhood. In this way, the residents could be informed and asked for feedback, without the influence of City elected officials or City staff. The consultant could assist in conducting the public hearing required under Kansas Statute prior to a decision by City Council on whether to proceed with annexation. Mr. Lasher suggested there are persons associated with Wichita State University who could be part of this consulting effort. There would probably be a cost to the City to retain such a consultant. Curt will reach out to individuals at WSU and, scheduling permitting, will invite one to be present at the next regularly scheduled City Council meeting to discuss the matter.

The mayor asked for the council's opinions on moving forward with the annexation. Ross, Janet and Curt are in favor of moving forward. Mike is not.

Janet asked Police Chief, Braden Moore, for an update on code enforcement progress.

Police department is continuing their efforts to contact residents with violations. He feels progress is being made and when Officer Liggett returns from vacation their efforts will increase.

Ross proposes City Council pay increase be considered in the future to be effective with each new term.
